# **News from the Park Administrator**

It's July! Summer has arrived and, with it, the rainy season. The pond is finally starting to fill up. The mosquitos are making their presence known. The yards have gotten greener, the mowers are whirring more often, and the temperature gauge has climbed. Yes, summer has arrived.

Earlier this month we had our annual Hurricane Preparedness meeting. We had the largest turnout since I have been here—of course, we offered cookies this time! We are grateful to Polk County Fire Rescue Public Education Manager, Kathy Sellen, for helping us prepare for the coming season. For those who are in the Park during the hurricane season, please ensure that everything outside your house or storage unit is securely protected from high winds—either move them to your house or storage unit or anchor them so that those items do not become wind-blown projectiles.

Earlier this year we started an audio/video center in Hood Hall. With the help of several people, we have made slow but steady progress. There is still lots of work to be done! Some drywall needs to be hung, some more cables need to be run, and some of the cables still need to be installed in the wall boxes. The walls will need to be painted when we get to that point. Some cabinetry work will need to be done later. Finally, before we can use the center, we will need to do lots of testing. If anyone in the Park during the summer is able to assist with any of this, please let me know so the project can be completed sooner.

Work continues on the Ebenezer/Zion water line. The people working on that had hoped to have it completed this month. Due to some unforeseen circumstances, the project has been delayed. However, it is well on its way to completion. It will likely be finished by the time the residents along those streets return to the Park.

Please welcome our newest maintenance staff person, Ryan Roberts. Many of you know his mother, Debbie Roberts, who has a place in the Park. Since Tom has been given the green

#### **News from the Board of Directors**

Summer is here. That of course means the rainy season in Florida and very warm and dry here in Michigan. So, send some of that rain our way!

A few weeks ago, we sent out to the membership our clarification on *Pets in the Park*. The following are some more details to add to that, starting with some definitions.

Emotional Support Animals - aka ESAs, is defined as an animal that provides a therapeutic benefit (e.g., emotional support, comfort, companionship) to a person with a mental health or psychiatric disability. Emotional support animals are not considered Service animals under Title III of the Americans with Disabilities Act, aka ADA.

<u>Service Animal</u> - aka Sas, (of which a dog can be an SA) is an animal that is <u>individually trained to do work or perform tasks</u> for the benefit of an individual with a disability, including a physical, sensory, psychiatric, intellectual, or other mental disability.

After careful research into what, if any, obligations the Light & Life Park has for Title III of the ADA or Florida Fair Housing Act, we have determined that **religious entities** are completely exempt from Title III of the ADA.

All their facilities, programs, and activities, whether they are religious or secular in nature, are exempt. Nothing in the Florida Fair Housing Act nullifies that. Therefore, we are under No obligation to allow any animals, not even Service dogs, in the Park.

Therefore, we believe that a clarification of the pet policy is in order. Upon review of the March 2021 ballot that was put forth to membership vote, it appears that the intent of the members' vote was to prohibit animals in the park. No thought was given to differentiating between pets, or Emotional Support Animals Service animals.

So, we recommend changing the rule for Pets to read "Animals", recognizing that not all animals are pets. We also believe that removing the 2-day allowance for visitors' pets is in order. Thus, no members' animals will be allowed in the park, except for a Service Dog, which will be determined on a case-by-case basis. The Rules and Regs committee will be putting together the changes to present to the Board at our next meeting.

Thank you all for your continued support, prayers, and patience as we continue to serve and represent you.

# REPORT OF PASTORAL DISCERNMENT TASK TEAM

June 27, 2023

I want to keep everyone informed about where the Pastoral Discernment Task Team is in working with the Conference MEGA Board. The Task Force works to inform the MEGA Board about the needs, wishes and dynamics of our unique congregation. The Task Force will not make the decision as to who will be the new pastor. The new pastor will be appointed by the Conference MEGA Board.

We met with Superintendent Mike McAvoy on Wednesday, June 21, for two hours. He led us in devotions from Acts 13:1-4. The passage describes how the Holy Spirit led the prophets and teachers, after they had fasted and prayed, to set aside Barnabas and Saul for a special work. Superintendent McAvoy then reminded us that Light and Life Free Methodist Church is God's church. God is the one who calls people to serve Him. God already has a pastor chosen for us. It is the task of the Pastoral Discernment Task Team to work with the Conference MEGA Board in discerning that choice

Superintendent McAvoy urged us to spend time as a church and Task Team fasting and praying for God to show us who He has chosen to lead us as pastor. We ask that you join us by fasting and praying for the MEGA Board and us as the Task Team.

The church BOA was asked to prepare a statement of the church's Purpose, Mission and Values. That has already been done and given to the Superintendent.

The Task Force shared with the Superintendent their expectations, giftedness. and qualities desired in a new pastor for this church.


