## News from the Park Administrator

It's starting to feel a lot like Christmas! Lights are being hung throughout the Park. Seasonal activities have begun. Although there aren't eight tiny reindeer anywhere, winter residents are returning, and several new members have arrived. It sure is great to see everyone and the increased activity in the Park.

One unexpected visitor recently was a cow named Patti. After several of us tried to corral the cow, the owners showed up at the gate looking for her. Initially, we thought the cow belonged to our farmer neighbor. Instead, the owners are from down Deeson Road. I heard that Patti is still on the loose, but not in the Park. It sounds like she escaped the spray field into the farmer's field. As a reminder, if you see cows in the Park, please contact me. I will take the necessary steps to get them where they belong.

In early November, I tested positive to COVID. Several of you have asked how I am doing. Fortunately, I never had any severe symptoms; basically, I felt like I had a bad head cold. I have, however, had some lingering fatigue. Thankfully, that has mostly passed. Thank you for your prayers and concern. I am reminded that people are still getting sick with this virus. So, if you are feeling ill, please stay home to protect others. In particular, do not participate in any Park group activities while you are sick.

These past few weeks I attempted to save the Park some money for trash removal by increasing the number of pickups per week instead of increasing the number of containers. It didn't work. Although the trash hauler stated they could pick up on Tuesday and Friday, it turned out that they couldn't pick up on Tuesday; they could only empty the bins on Wednesday and Friday. This meant the two bins had to hold all the trash from Friday until Wednesday. Since that experiment didn't work, we have increased the number of bins to four and will increase them again as more people arrive. Here are some reminders regarding trash:

- Make certain all household trash fits completely in the dumpster and close the doors of the. We do not want to

encourage the alligators or raccoons to go dumpster diving.

- Place nothing but clean, empty, flattened corrugated cardboard in the recycling bin (cereal and tissue boxes are NOT corrugated cardboard). Pizza boxes, although they are corrugated cardboard, must be placed in the regular trash as they are often greasy. Recently, I have seen Styrofoam and plastic bags in this dumpster
- Do NOT place tires in any of the containers. If you replace tires on your car or golf cart, you are responsible for taking them to a tire recycling facility.
- Place aluminum cans in the appropriate barrel in the white fenced area. We collect these and sell them for the Park.
- 

If you haven't visited the goats yet, please take the opportunity to do so. The white goats are very cute and fun to watch. If one of the older ones gets their head stuck through the fence, let either Mike or me know; we will make sure it is freed. I know when you visit them, you want to feed them. However, when you do, please feed them from your hand to their mouths. Food thrown on the ground can lead to illness. Also, **never** throw any food into the overnight shelter (it is also where the newest kid goats are). The ground in that area is especially littered with droppings that can make the goats sick.

As more and more of you return to the Park, it is really important that we follow all posted and understood rules of the road. Always yield to pedestrians and bicyclists (it is Florida law, after all). Stop at the stop signs and look before proceeding. Drive on the right-most side of the roadways. Keep your speed at 15 mph or lower—I know it's hard, but safety is much more important than the little time it saves if you go faster.

I wish you all a blessed, happy Christmas. Enjoy your family and friends. Celebrate Jesus—the real reason to celebrate. We'll be back in touch next year.

The anticipation of a good winter season seems intensified after the last year of COVID and not being able to do things as we once did. We still don't know what is ahead, but more are confident about returning and are excited for another winter in Light and Life Park.

Changes are coming soon in the Laundromat. The machines will be changed as soon as Axon gets them ready. They will only handle credit cards or an APP on your phone. We will share the details of that when they become available. Quarters have gotten scarcer since COVID began and the laundry service has been changing to accommodate that situation.

LIBRARY2GO will be returning in January. They have been out to collect the books that I held after the COVID situation started. We will be on the same 3-week rotation schedule on Thursdays.

Ruby Smith volunteered to help in the Park Office so you may see her there occasionally. We are building a history of owners by lot in the Park. This has been on-going for a few years, and we are glad for her help.

Speaking of lots, there have been some changes. While 5321 Hebron was our only lot last month, it looks like it may be leased soon. 5332 Ebenezer is now available again as Flaugh's have purchased Cheryl Cooper's place on 5302 Zion Avenue. 5325 Ebenezer Place is currently available, although a prospective buyer is interested.

Speaking of buyers, we are in a new situation with sales of homes. If you are going to sell to someone at this point, the first question you need to ask them after you ask if they have been approved for membership is if they are Free Methodist. We have reached the maximum number of Non-FM members that we can have. This means Free Methodist applicants will be able to purchase first until the requirement is modified or we reach a balance of more than 75% FM.

**News from the Board of Directors**

Hello Members, Renters and Guests, Your Park is now forever changed (in our lifetimes). The two large old Oak trees on the north side of Shiloh are gone. Some of you may not notice much, some may be relieved and some may be upset.

Your Board and Park Administrator form what could be referred to as a little government. With the number one purpose of a government being to help assure the safety of its membership, we took this action. Large old trees are objects we respect and want. But these two presented increasing risks. They had begun declining.

An Arborist had pointed out how they had begun dying - we could see that some of the small limbs at the top had died. We would expect this continue and work back to the larger, and

heavier, parts of the many limbs. To the south, the southern tree had grown over TECO's power wires. To the east they reached over the Reisman's carport and house. On the west side they reached over the Merrill house. The tree to the north leaned toward the Foster's house. If we waited longer, falling limbs could have caused considerable damage, and if a (whole) tree fell the damage would have been far greater.

An Arborist said he could remove the trees and grind up the stumps for somewhere over \$11,000. We got two other bids for \$8,000. and \$7,500. We had this done by a son and father team for \$4,900. I am in Michigan now. I have been sent photos as the work progressed. It appears it was completed yesterday (Nov. 9). With skill, experience, the right equipment, and father/son teamwork, it appears that this huge job was completed in 3 working days. To me it is remarkable. I also have a feeling of loss. Some long-term history is gone.

We want to purposefully plant some trees. I recall a hay farmer who had planted about 7,500 trees on his property (Betty and I have "only" planted about 200 on ours). This farmer was an avid hunter. He told me he carried acorns with him. When he harvested a deer, he would plant a few acorns as kind of a thank you and a kind of life replacement.

Anyhow, I wanted to explain the history of our action. Each year, around our Park, we have needed to keep picking up limbs, removing dead trees, trimming limbs, etc. Your safety and wellbeing are priorities we take seriously.

In searching the stacks for a different Christmas fiction book at our library, I came across one that caught my eye, *The Judge Who Stole Christmas*. This should be an easy, light read. How can a judge steal Christmas?

In a Virginia town called Possum, a legal battle was about to unfold. Visualize an image of a small-town couple, Thomas & Theresa Hammond who are participating in the annual live nativity, set up in the town square. It's drizzling, people drive by to see Mary and Joseph with baby Jesus. The Hammonds are enjoying the comments made by a family and their hearts are warm with the kind words. A baby born to a virgin was definitely that, a miracle!

A man drives up and demands that they shut down the Nativity set *NOW!* As a lawyer for the ACLU, he meant business, handing over documents containing a lawsuit to cease and desist with portraying Mary and Joseph. It was an issue of separation of church and state.

A federal judge rules the display unconstitutional; battle begins. Thomas refuses to obey the court and ends up in jail. From the courtrooms of Virginia to the talk shows of New York City, the battle escalates into a national media spectacle. Caught in the middle is law student Jasmine Woodfaulk, assigned to represent Thomas as part of her school's legal aid clinic.

The faith of the people in Possum shows miracles can happen even with the government. It is suspense, a thriller along with being an example of healing. This is a must read. Find it in the S section of fiction.

**A Note from Pastor Chuck...**

The 1879 Free Methodist Book of Discipline (BoD) is actually titled, "DISCIPLINE OF THE FREE METHODIST CHURCH." This is not a big or significant change. As I have looked inside the 1879 version, I see interesting sentence construction. I see a way with words that is different from language usage today.

I read a different BoD than what was written in 2019. As time moves on the area of interests change. Our Articles of Religion stay consistent and yet are re-written with some areas expounded and a few areas reduced. "We" used to be opposed to "singing special" numbers and "choirs" were forbidden. For a musical people this caught me by surprise yet over time "reasons" for some stands or positions change.

What does not change is God and His Word. Free Methodists have been consistent in holding firm to our understanding of who Jesus is and the dependability, accuracy, infallibility of God's Word. Isn't it encouraging to know God and know that He is the same yesterday, today and tomorrow? God is good! Come and see.
