## News from the Park Administrator

For the last four months it has been a beehive of activity in the Park. Suddenly, the streets are nearly empty. Where did everyone go? They went home... to Alabama, Illinois, Iowa, Indiana, Kentucky, Michigan, New York, Ohio, Oklahoma, Ontario, Pennsylvania, Saskatchewan, Tennessee, Texas, Virginia, Wisconsin, or West Virginia. That means our members represent 15 states and 2 provinces, and that doesn't include those who have made their permanent residence here who are from other locations. Remarkable!

Gloria and I enjoyed a brief respite in early April. We visited beaches on the gulf coast and nature preserves near the everglades. It was refreshing to break away for a short time. One of the highlights of the trip was to see a momma alligator watching over her brood of 17 babies; she was carrying one of the babies on her back! For the first time since we began using Zoom for our organizational meetings, I had the opportunity to be a remote participant. It was satisfying to note that the audio and video quality were excellent. I was also pleased to see how a parliamentary procedure question was handled. Our Bylaws do state that we are to follow Robert's Rules of Order. In this incident, the Order question was resolved exactly how it should have been. A sidebar was called, the question discussed, and the question corrected. Thank you to the one who brought the question to the floor. Everyone should thank the Board members and the parliamentarian for resolving the question in an orderly fashion.

The offer for the purchase of a nearby parcel of property was recently delivered to the owner. Be in prayer as we move forward. The decision is being delayed by personal concerns of the owner, so I cannot say when an agreement will be reached. However, I will keep you informed when there are updates.

Most of you are likely aware that our public health officials continue to caution us about the resurgence of COVID in mutated forms. Remember that the best thing you can do to

do to limit the spread of any disease—whether it is COVID or some other illness—is to stay home when you are sick.

During the summer, the Park will be mowing the grass around the residences. However, our staff does not trim around the residences; that is the owner’s responsibility. Therefore, if you are an owner, you need to contract with someone to do your trimming. If we notice a residence that is not being trimmed, we will follow the guidelines set out in the rules (see section 3.1.m, Rules & Regulations, Revised March 2022) to ensure that the entire Park looks great throughout the summer. Call the office if you do not know who does lawn trimming.

Hurricane season starts next month. If you are leaving the Park for the season, you must ensure that you have “wind-proofed” your residence. Here are some steps you need to take BEFORE you leave. If you are not able, please seek assistance from others in the Park.

- If possible, move everything that is outside your residence to a secure indoor location.
- If you have items that cannot be moved indoors, ensure that those items will not become wind-blown missiles. Tie outdoor items down if they are not heavy enough to withstand strong winds.

We will be conducting a hurricane preparedness meeting sometime soon for those remaining in the Park during the summer.

While you are enjoying family and friends this summer at your other homes, we will keep your Park ready for your return. Have a great summer!

Meet Daphne Beekman, a mystery writer by day, inquiry agent (private investigator), by night. Soon Daphne finds herself involved in an attempted murder case she's determined to solve.

### Stamps for Missions

All donated stamps are sent to Alliance Stamp Ministry in Fort Myers where they are sold to dealers. The money is sent to a publisher in Buenos Aires, Argentina where they publish Sunday school material in Spanish that are sold to at least eight Latin American Countries as well as Spain and the US. They are used by over 40 Protestant Denominations. It costs \$9.60 to mail a shoebox full of stamps.

Try to leave at least 1/4 inch or more around each stamp or strip of stamps.

They now collect picture post cards both unused and used. If used, please leave the stamps on the cards. Thank you.
